Re: Assembly Bill 488 of the 83rd Legislative Session

Dear Secretary of State Aguilar:

I am forwarding to you, for filing within the time limit set forth in the Nevada Constitution and without my approval, Assembly Bill 488 ("AB 488"), which is titled as follows:

AN ACT relating to criminal procedure; revising provisions relating to vacating a judgment of conviction and sealing certain records of certain victims; and providing other matters properly relating thereto.

There is no question that victims of sex-trafficking deserve unique protection under the law. However, AB 488 is inartful in its approach to addressing the needs of victims of sex-trafficking.

First, the bill provides that a "qualified party" must confirm whether a person is a victim of sex-trafficking. The term "qualified party" is overbroad in that it applies to non-profit organizations, without requiring independent verification of the petitioner's status as a victim of human trafficking. When the stakes are as high as the potential sealing of a criminal record, even for a charge as severe as homicide, it is more appropriate for that determination to be made by law enforcement and/or a healthcare provider. Additionally, even the "qualified party['s]" affidavit in support of record sealing need only state that the person "sought assistance from the qualified third party relating to the victimization experienced by the petitioner from human trafficking[.]" Effectively, this would mean a nefarious defendant could seek assistance—without actually being a victim—and still have

their records, related to <u>any</u> type of crime, sealed. Finally, AB 488 limits a court's inquiry into whether a defendant has truly been rehabilitated. This is an unsupportable proposition because the court could find that a defendant needs additional treatment or supportive services to heal from trauma and would have no means to ensure the provision of such treatment or support.

For these reasons, I veto this bill and return it without my signature or approval.
