



COVID-19 BY THE NUMBERS - NEVADA




STATE OF NEVADA COVID-19 UPDATES

[APRIL 24, 2020] The Nevada Department of Health and Human Services, Division of Child and Family Services is asking for the public's help amid a drop in suspected child abuse and neglect reports. While everyone is Staying Home for Nevada, children may be at a greater risk of abuse and neglect as many families are experiencing stress over things such as work, health issues, and educating children at home. As children are not in daycare or school, many of the mandatory reporters who typically spot signs of abuse and neglect and are required to report do not have contact with these children. [APRIL 24, 2020] U.S. Senators Jacky Rosen and Catherine Cortez Masto released a statement following the news that the U.S. Treasury Department has decided to allow all gaming small businesses to participate in the Paycheck Protection Program (PPP). Prior to this reversal, the U.S. Department of Treasury excluded any small business that derives more than one-third — later revised to more than one-half with a \$1 million cap — of their revenue from legal gaming activities from participation in PPP. Both Senators have been active in fighting for the rights of Nevada's small businesses as related to the CARES act, including introducing the Equal Access to COVID-19 Relief Act in the Senate. [APRIL 24, 2020] Data finalized this week by the Nevada Department of Employment, Training and Rehabilitation show initial claims for unemployment insurance totaled 39,496 for the week ending April 18, which is a 32.6 percent reduction compare to the prior week. This is the second straight week that initial claims have fallen. Thus far in 2020 there have been 369,670 initial claims filed, which is more than any other full calendar year in state history. Current claims, which represent the current number of injured unemployed workers filing weekly for unemployment insurance benefits, rose to 231,618, a 22.5 percent increase from the prior week. This places Nevada's insured unemployment rate at 16.8 percent, also the highest rate in State history. [APRIL 24, 2020] The Nevada Aging and Disability Services Division announced that they have been awarded \$6,929,262 in grants from the Administration for Community Living (ACL) as part of the CARES act. These funds will be used to help meet the needs of older adults and people with disabilities as Nevada communities implement measures to prevent the spread of COVID-19. The monies will go to support and enhance nutrition services, home care services, respite care and other general support to both families and caregivers. 

The Mardi Gras festival, bringing more than 1 million visitors to New Orleans late February, before municipalities around the nation took action, left it vulnerable to the COVID-19 pandemic. San Francisco, one of the earliest large metropolitan areas to implement a city-wide shelter-in-place, has seen fewer cases, deaths per capita.







U.S. STATE DEPARTMENT

LEVEL 4 – DO NOT TRAVEL

The Department of State advises U.S. citizens to avoid all international travel due to the global impact of COVID-19. In countries where commercial departure options remain available, U.S. citizens who live in the United States should arrange for immediate return to the United States, unless they are prepared to remain abroad for an indefinite period. At present the Department of State is making every effort to assist U.S. citizens overseas who wish to return to the United States. As the Covid-19 situation develops, our ability to provide such assistance working with commercial airlines or arranging for evacuation flights may become more limited or even unavailable. In recent weeks, commercial airlines have significantly reduced flight schedules and countries have closed airports and borders with little advance notice. If you wish to return to the United States, you should make arrangements to do so now and contact the nearest U.S. Embassy or Consulate for assistance as needed. There is no guarantee that the Department of State will be able to continue to provide repatriation assistance and transportation options to the United States may be unavailable in the future. If you choose to remain overseas, you should be prepared to remain where you are for the foreseeable future. U.S. citizens who live abroad should avoid all international travel.

CENTERS FOR DISEASE CONTROL

LEVEL 3 – AVOID NONESSENTIAL TRAVEL

- Widespread ongoing transmission of a [respiratory illness caused by the novel coronavirus \(COVID-19\)](#) is occurring globally.
- **CDC recommends that travelers avoid all nonessential international travel.**
- Older adults and people of any age with serious chronic medical conditions are at increased risk for severe disease.
- There may be limited access to adequate medical care in affected areas.
- US residents may have difficulty returning to the United States.
- Travelers should avoid contact with sick people and wash their hands often with soap and water for at least 20 seconds. If soap and water are not readily available, use an alcohol-based hand sanitizer that contains at least 60% alcohol.
- All international travelers should stay home for 14 days after returning from travel, monitor their health, and practice social distancing.
